### **INVITATION TO BID**

# CONSTRUCTION OF ONE (1) STOREY - TWO (2) CLASSROOMS (WITH COMMON TOILET AT TUGAS ELEMENTARY SCHOOL, LAAK DAVAO DE ORO SDDO-002-2023

The Department of Education Division of Davao de Oro, through the General Appropriations Act (GAA) intends to apply the sum of Five Million Eight Hundred Ninety Two Thousand Seventy One Pesos and Twenty-Nine Centavos (5,892,071.29) being the ABC to payments under the contract for CONSTRUCTION OF ONE (1) STOREY – TWO (2) CLASSROOMS (WITH COMMON TOILET) AT TUGAS ELEMENTARY SCHOOL, LAAK DAVAO DE ORO (SDDO-002-2023). Bids received in excess of the ABC shall be automatically rejected during the bid opening.

The Department of Education Division of Davao de Oro now invites bids for the above Procurement Project. Delivery of the Goods & Service is required by **120 calendar days**. Bidders should have completed, within 2021 from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Prospective Bidders may obtain further information from Department of Education Division of Davao de Oro and inspect the Bidding Documents at the address given below from 8:00 A.M. to 4 P.M. excluding Holidays, Saturdays and Sundays.

A complete set of Bidding Documents may be acquired by interested Bidders on **June 01**, **2023 (1:00 P.M.)** from the given address and website(s). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or through electronic means.
