## **INVITATION TO BID**

# PROCUREMENT OF LEARNING TOOLS & EQUIPMENT (TVL TOOLS) FOR THE IMPLEMENTATION OF THE REDESIGNED TECH-VOC HS PROGRAM PACKAGE (SDDO-015-2023)

The Department of Education Division of Davao de Oro, through the General Appropriations Act (GAA) intends to apply the sum of **One Million Forty-Seven Thousand Four Hundred Forty-Eight Pesos and Seventy-Five Centavos (P 1,047,448.75)** being the ABC to payments under the contract for **PROCUREMENT OF LEARNING TOOLS & EQUIPMENT (TVL TOOLS) FOR THE IMPLEMENTATION OF THE REDESIGNED TECH-VOC HS PROGRAM PACKAGE (SDDO-015-2023)**. Bids received in excess of the ABC shall be automatically rejected during the bid opening.

The Department of Education Division of Davao de Oro now invites bids for the above Procurement Project. Delivery of the Goods & Service is required by **30 calendar days**. Bidders should have completed, within 2022 from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

Prospective Bidders may obtain further information from Department of Education Division of Davao de Oro and inspect the Bidding Documents at the address given below from 8:00 A.M. to 4 P.M. excluding Holidays, Saturdays and Sundays.

A complete set of Bidding Documents may be acquired by interested Bidders on **November 20, 2023 (1:00 P.M.)** from the given address and website(s). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or through electronic means.
