

Golden greetings!

This is to respectfully request your good end for the extension of stay of fifty (50) families that are temporarily staying at Elizalde National High School.

As you may know, the Inter-Agency Task Force for Relocation, has issued pre-emptive notice to the communities of Bunlang, Masara and Biucadan, Teresa on the impending threat of landslide that will affect their respective communities. On this measure, some of the residents heeded to the call of the agency and temporarily relocate themselves at Elizalde National High School.

The Apex Mining Company, in our efforts of ensuring the safety of our community residents, committed to assist the affected families of the said communities, by providing the following measures:

- 1. Provision of financial assistance in the amount of Fifty Thousand Pesos (Php50,000.00) per evacuated families; and
- 2. Provision of vacant lot at Brgy. Calabcab, Maco as the permanent relocation site of the affected families

In spite of our efforts, the assistance mentioned above did not materialize because of the following concerns:

- 1. The Fifty Thousand (Php 50,000.00) financial assistance was not released to evacuated families because some of their families member/s continued staying at the danger
- 2. The Company Property at Malamodao was utilized as temporary shelter for the affected families of Masara Landslide; and
- 3. The Company Property at Barangay Calabcab was not developed because the adjoining lot owner continue to hinder the development of the said lot. The Barangay Government of Calabcab and Municipality of Maco cannot agreed on terms to settle the matter.
