Re: Request for endorsement for collection of fresh stool samples in selected schools in Maragusan, Davao De Oro

The University of the Philippines (UP) Neglected Tropical Diseases Study Group (NTDSG) in collaboration with the Department of Health - Davao Center for Health Development is implementing a project entitled "A Machine Learning-Based Mobile Application and Cloud Platform to Enable Accurate and Streamlined Surveillance of Soil-Transmitted Helminth Infection and Schistosomiasis" (UP Manila Research Ethics Board Code: 2021-0742-01), in collaboration with Parasite ID, Corp., USA and PATH, USA. The project aims to enhance surveillance of parasitic neglected tropical diseases in the country through the development of a mobile application that will utilize artificial intelligence for the detection and identification or parasite eggs.

To date, the project team has developed a well-trained Al powered application which is now ready for the next step that is the conduct of a feasibility study in a field setting. This step necessitates a pilot study that prepares the way for the full-blown feasibility study which is scheduled in November 2024. The proposed pilot study will generate data to compare conventional microscopy to the newly trained Al application and is proposed to be implemented in collaboration with the local government unit in Maragusan, Davao de Oro from August 26-30, 2024. The pilot study will involve collecting fresh stool samples, at least five (5) grams each, from children aged 9 to 17 years from the 1) Mapawa Elementary School and 2) Tigbao Integrated School in Maragusan for the said sample collection.

As such, we are respectfully requesting your endorsement to the school heads of the above-mentioned schools to facilitate collection of stool samples for our pilot feasibility study this coming August 26-30, 2024. We will ensure strict compliance to health and safety protocols in all activities, including minimizing contact with the participants, identifying designated drop-off points for stool samples, and the provision of personal protective equipment for all field personnel.

In preparation for the above-mentioned activity, we would also like to invite you and the following persistinel to a coordination meeting and groundwork visit on August 13, 2024, 1:00 PM. We will be discussing the planned activities and logistical preparations needed for the upcoming parasitologic assessment and pilot study.
