Pursuant to Republic Act No. 11036 or an "Act Establishing a National Mental Health Policy for the Purpose of Enhancing the Delivery of Integrated Mental Health Services, Promoting and Protecting the Rights of Persons Utilizing Psychosocial Health Services, Appropriating Funds Therefor and Other Purposes", the Department is mandating to promote and uphold the mental health of every learner utilizing available psychosocial health services.

In view thereof, this Region through the Education Support Services Division will conduct **Formulation of Socio-Behavioral Change and Communication (SBCC) Materials for School Mental Health Program on September 23-27, 2024 at The Ritz Hotel at Garden Oases**, which aims to communicate to learners their rights, safety, and protective mechanisms for them to avoid to fall on mental health disorders.
