
PSYCHOLOGICAL FIRST AID

- In Relation to Republic Act 11036, also known as the Mental Health Act, an act established for the purpose of enhancing the delivery of integrated mental health services, the Department of Education is committed to develop strategies for Mental Health promotion in basic education.
