

TERMS OF REFERENCE OF THE DELEGATION OPERATION MANAGEMENT, WORKING COMMITTEE AND EVENT MANAGEMENT

A. General Operation Management

A.1 Technical Advisory Council

- A.1.1 Provide technical advices and afford resolution to any form of conflict that may arise.
- A.1.2 Elevate and relay to delegation and/or co-delegation head matters need the decision of the latter.
- A.1.3 Ensure decision of the council and the delegation and/or co-delegation delivered to concerns.

A.2 Delegation Management

- A.2.1 Oversee the operation of the delegation: committees and event management.
- A.2.2 Coordinate to host school on administrative matters, delegation concerns and related activities.
- A.2.3 Update the delegation and/or co-delegation head of the situation of the delegation.
- A.2.4 Relay to advisory council to secure advices and resolution to any conflict that may arise.

A.3 Finance Committee

- A.3.1 Require the program owner submission of Activity Design and other necessary financial documents
- A.3.2 Ensure utilization of Special Needs Education (SNED) downloaded funds bounded with the PMIS
- A.3.2 Facilitate utilization of Special Needs Education (SNED) downloaded funds

A.4 Billeting Quarter Management

- A.4.1 Make inventory, account and keep record of properties inside the classroom.
- A.4.2 Secure keys and endorse to assigned occupants of the classroom.
- A.4.3 Ensure security of the camp: free from hazards, spaces are child-friendly, ramps and stairs are free from obstacles.
- A.4.4 Warrant camp securely guarded: classrooms are closed when learner-participants and coaches are out.
- A.4.5 Sustain cleanliness inside and outside classrooms: ensure learners-participants and coaches' clothes and beddings are properly kept.
- A.4.6 Provide waste disposal bin: biodegradable, non-biodegradable and hazardous are properly segregated.
- A.4.7 Take control and set sleeping and waking time.
- A.4.8 Report to host school and secure immediate action when problem arises pertaining to water supply and electricity.
- A.4.9 Prepare and submit report and accomplishment when required.

A.5 Medical Services

- A.5.1 **Medical Care**: Provide immediate first aid and medical care for any participants who require assistance during the event.
- A.5.2 **Emergency Response**: Establish and communicate emergency response procedures and coordinate with local healthcare facilities for severe cases.
- A.5.3 **Medical Supplies**: Ensure an adequate supply of essential medical equipment, first aid kits, and medications at the medical station.
- A.5.4 **Medical Records**: Maintain accurate records of medical interventions, injuries, and treatments provided during the event.
- A.5.5 **Communication**: Maintain open and effective communication with event organizers, security personnel, and local authorities to address any medical concerns promptly.
- A.5.6 **Safety Measures**: Oversee the implementation of safety measures and first aid stations throughout the event area.
- A.5.7 **Briefing**: Conduct briefing sessions for medical staff and volunteers, including familiarity with the event layout and any special needs participants.

A.6 Transportation Committee

- A.6.1 Secure vehicle for the delegation.
- A.6.2 Ensure all coaches and learner-participants accounted before heading to the venue.
- A.6.3 Ensure delegation securely traveled to the venue thus, drivers shall be oriented that passengers are vulnerable.

A.7 Mess/Food Committee

- A.7.1 Contact caterer to ensure food delivered on time.
- A.7.2 Set up area where food packs are set for inspection prior to distribution.
- A.7.3 Check food packs and ensure enough to the number of pax.
- A.7.4 Distribute and serve food to the delegation.

A.8 Secretariat

- A.8.1 Keep records and profile of the delegation: coaches and learner-participants
- A.8.2 Keep updated record of schedule and venue of the event; post the same within the vicinity of the secretariat quarter for delegation information
- A.8.3 Receive queries and relay same queries to concern committee for action and resolution
- A.8.4 Receive results of every event submitted by coaches; summary shall be crafted and posted for delegation information

A.9 Learners Rights Protection Desk

- A.9.1 Establish a learner rights and protection hub
- A.9.2 Address the learner rights and protection concerns on 24/7 basis through provision of helpline
- A.9.3 Source out assistance of the Municipal and Provincial Social Welfare and Development Officer
- A.9.4 Facilitate referral mechanisms of any incident related to learners' welfare.

B. Event Management

B.1 Event Coordinator

- B.1.1 Coordinate with the event in-charge for schedule and venue of the event.
- B.1.2 Update the coach on the update of the event schedule & venue and other related concerns of the event
- B.1.3 Report to secretariat the updated schedule of event and venues for record purposes

B.2 Event Monitors

- B.2.1 Monitor the learner-participants and coach in their respective event assignment
- B.2.2 Ensure learner-participants and coach of the event are there in the venue, if and when found coordinate with the event coordinator to know whereabout of the participants.
- B.2.3 Report to the secretariat update, findings and result of the monitoring done

B.3 Coach

- B.3.2 Coach, update, inspire and defend learner-participants in and out of the event venues
- B.3.3. Establish open communication to the secretariat on the updates of the event schedule and venue
- B.3.4 Ensure learner-participants abide by rules and regulations in the camp, activity venues and other places they are in and situated.
- B.3.5 Coordinate with food service committee on the food requirement of the learnerparticipants
- B.3.6 Submit result of event to the secretariat for recording and updating purposes

B.4 Assistant Coach

- B.4.1 Assist the coach before, during and after the event participated
- B.4.2 Support the coach to ensure plan and strategies of the event well implemented
- B.4.3 Back up the coach on event schedules and all rules and regulations of the event set by the management
- B.4.4 Take over the coach in case of emergency and that the coach cannot perform his duties and responsibilities
