

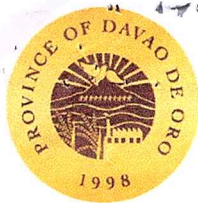
Subject: **ATTENDANCE TO COORDINATION MEETING AND ORIENTATION
