CONTRACT AGREEMENT

Obrero, Davao City, Philippines (*hereinafter called "the Supplier"*) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SUPPLY & DELIVERY OF PRINTERS FOR THE 2024 PRODUCTION & DISTRIBUTION OF LEARNING EXEMPLARS & WORKSHEETS LOT 1 (SDDO-026-2024-LOT 1)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Six Million Five Hundred Thirty-Seven Thousand Eight Hundred Eighty-Eight Pesos (P 6,537,888.00)** (*hereinafter called "the Contract Price"*).
